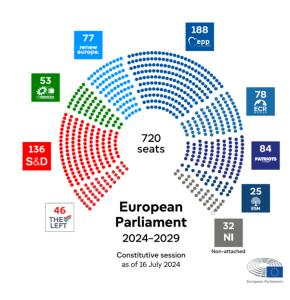
What is the European Parliament?

- The European Parliament's official seat is located in Strasbourg, France it also meets in Brussels, Belgium.
- It is the only directly elected EU body and represents citizens of the EU.
- Elections for MEPs have been held every five years since 1979.
- The European Parliament's powers have steadily increased with each change of the EU treaties that determine their powers.
- Many laws in member states now stem from the need to implement European legislation made in the European Parliament.



The creation of the European Parliament

- On March 19th of 1958 the European Parliamentary Assembly met for the first time.
- The Assembly was formed by expanding several other communities: the European Assembly of Coal and Steel Community, European Economic Community and European Atomic Energy Community.
- The Assembly was renamed the European Parliament on March 30 1962.
- Its main role is to ensure the democratic legitimacy of the European Law.
- This shows how it is organised with different parties/political groups.



Political Groups

- There are eight political groups in the current parliament
 - The group of the European people's parliament
 - Group of the Progressive Alliance of Socialists and Democrats
 - Renew Europe
 - Group of the Greens/European Free Aliance
 - European Conservatives and Reformists Group
 - Patriots for Europe
 - Europe of Sovereign Nations
 - The Left Group in the European Parliament
 - Some MEP's sit as non-attached MEP'sknown as non-inscrits.

- Over the nine terms that the EP has sat, the number of MEPs, Member states, political groups and the number of national political parties have increased and sometimes shrunk.
- For example:
 - Session of 1979-84: 410 MEPs.
 Session of 2014-19: 751 MEPs.
 Session of 2024-29: 720 MEPs
 - Session of 1979-84: 9 member states. Session of 2014-19: 28 member states. Session of 2024-29: 27 member states

Electoral system

- The EP has up to 720 seats.
- MEPs are elected for these seats under national electoral systems, but these have to observe common principles established in EU law.
- Almost all Member States allow the possibility to vote from abroad in EP elections.
- The Amendments to the 1976 Electoral Act state that Member States may provide the possibilities of advance voting, postal voting and electronic and internet voting in elections to the EP.
- The minimum age to be eligible to vote and to stand as a candidate in the European election is established by national law. In most Member States, it is 18. In Greece it is 17, in Belgium, Germany, Austria and Malta it is 16.
